**Exhibiting Agreement**

This exhibitor's agreement to display works of art with the Goshen Art League includes all League events and exhibits in which you participate until such time as you rescind this agreement in writing.

Every reasonable care will be taken with submitted works. However, neither the exhibit host, the Goshen Art League, its officers, or volunteers will be responsible for theft, loss, or damage to works however incurred. Your entry into an exhibit constitutes agreement with these terms. By signing this agreement the artist waives any rights to a law action suit against the Goshen Art League, its agents, or hosts.

Artwork must be suitable for display in public areas. Accepted work must be framed, gallery wrapped, or otherwise suitable for exhibiting, and ready for hanging with **picture wire only**. Works with saw tooth hangers, clips, etc. will not be hung. The Goshen Art League reserves the right to turn away works that are not securely framed, still wet, unstable, or in any way hazardous to the work itself, other works, or the exhibition personnel or viewing audience. Arrangements must be made in advance of delivery for any works that do not conform to this traditional hanging method.

Artist agrees to report all sales, including dollar amount, resulting from Goshen Art League exhibitions to the League, such report to be in writing or via email-[goshenartleague@gmail.com](mailto:goshenartleague@gmail.com), no later than one week after the exhibit closes.
