Labels for the exhibition are prepared in advance, so your email submission must include ALL of the following for EACH PIECE. Please follow this EXACT format FOR EACH PIECE and submit in regular text in the body of your email (not as an image, not as a PDF, etc.) The info you provide is copied and pasted to create your label(s).

- Submit family friendly work suitable for a lobby in a public office building.
- All styles from traditional to abstract to conceptual are welcome and encouraged.
- Small-medium sculptures, fine jewelry and 3D works accepted. (Helpful if artist can supply pedestal, but not mandatory). There is limited tabletop and display cabinet space for the sculptures so they are accepted on a first registered, first served basis. Please contact us with any questions **WELL** in advance of delivery date.
- All works must be **WIRED** and ready for hanging. No sawtooth or other type of hanging hardware will be accepted. If you have any questions email us **WELL** in advance of delivery date.
- GAL reserves the right to refuse any works that are unsafe, improperly framed or wired, still wet, or unsuitable for hanging in any other way.
- Works must be delivered and retrieved on dates and times indicated. This is a public lobby space. Artworks cannot be stored. If you have any problems with the agreed upon times, contact GAL via email **WELL** in advance. If you cannot pick up your works as indicated, please make arrangements with a representative to do so. If a representative is dropping

off your work, be certain that they have **ALL** the necessary information and are prepared to take the time to sign in for you properly.

- Only artworks will be accepted at the site. All protective wrappings and carrying devices must be removed by artist/representative and taken from premises.
- All works must remain until the end date of the show. If you wish to remove a piece that has been sold, Goshen Art League must be notified, and the piece must be replaced with a work of the same size. **A REPRESENTATIVE OF GAL MUST BE PRESENT AT ALL TIMES FOR THE REMOVAL OR INSTALLATION OF ANY ARTWORK FOR ANY REASON.** It is likely this show may see more sales than usual. We would like to have buyers take the work with them, since some may be holiday gifts. Please consider having something on stand-by to hang in place of any works that sell.
- Upon delivery of your work, you will be asked to indicate some sort of finger food you may like to contribute for the reception. Both savory and sweet items that can be eaten without utensils and from a napkin are welcome. GAL will supply beverages.
